- 12) CAMHS have staff trained in EMDR. There are no adaptations made. CYP with autism are able to access this depending on the nature of their cognitive and autism needs.
- 13) Yes, although this is not formally adapted for autism but adjustments are made.
- 14) Knowsley Occupational Therapy is adapted for autism.
- 15) CAMHS require staff to attend autism training.
- 16) Yes.
- 17) Yes, options for appointments are offered. However, e-mails are not a preferred means of communication with CYP.

Local neurodevelopmental training is commissioned through Advanced Solutions which can be accessed by frontline professionals free of charge. We are also part of an autism in schools pilot, which includes wider workforce development.
